

## **New Year's Resolution - Sweepstakes OFFICIAL RULES**

### **NO PURCHASE, OBLIGATION OR TRANSACTION NECESSARY TO ENTER THE SWEEPSTAKES.**

**PROMOTION PERIOD:** The New Year's Resolution Sweepstakes ("Sweepstakes") begins December 1, 2014 and ends February 28, 2014. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

**HOW TO ENTER:** Individuals will receive an automatic entry into the Sweepstakes when they log into Collins Community Credit Union between December 1, 2013 and February 28, 2014, and have created at least one financial goal. One entry per individual.

COLLINS COMMUNITY CREDIT UNION and Geezeo assume no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. Mail-in entries must be postmarked no later than February 28, 2014 and received by March 4, 2014. Proof of mailing does not constitute proof of delivery. Geezeo is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries or mail. Mechanically reproduced entries will not be accepted. Alternate entries are limited to one per person. Once submitted, all entries become the property of Geezeo and none will be returned.

**ELIGIBILITY:** Entries are open to the general public. No purchase necessary. To qualify for the Sweepstakes, entrants must be 18 years or older.

**Employees, Board volunteers and consultants of COLLINS COMMUNITY CREDIT UNION and its subsidiaries, and their family members within the same household are not eligible to win.**

**Sweepstakes subject to all applicable federal, state and local laws. Sweepstakes void where prohibited or restricted by law.**

**AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Geezeo, which are final and binding in all matters relating to this Sweepstakes.

**SELECTION OF WINNER:** Winner will be chosen by random selection the week of March 7, 2014, from all eligible entries received during the Promotion Period from all participating financial institutions. There will be a total of one (1) winner for the \$1,000 Grand Prize and one (1) winner for the \$500.00 First Prize.

For a selected entry to be declared a winner, the winning individual must satisfy all of the requirements as listed in these Official Rules. Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.

The arrangement of the prize distribution will be handled between the Prize Winner and Geezeo/COLLINS COMMUNITY CREDIT UNION. The odds of winning are approximately 1 in 30,000; however, actual odds of winning will depend upon the number of entries received from all participating financial institutions.

Final determination of winners will be made by a staff member of Geezeo, whose decision is final.

Arbitrator decisions are as enforceable as any court order and are subject to **VERY LIMITED REVIEW** BY A COURT. The place of arbitration shall be in the County in which you reside.
